LABF Staff Healthcare 2025 Renewal

Mr. Mock presented information regarding the renewal of medical, dental and vision insurance coverage for LABF's staff and eligible staff retirees for 2025, including historic costs for comparison purposes. Mr. Mock gave some background on the plans and reported on the components that made up the increase in healthcare costs from 2024 to 2025.
